Local Law #3 of the Year 2021

A Local Law titled "Amending Local Law #5 of the Year 1995, titled Repealing Local Law #2 of 1978, Filling Vacancies on the Board of Legislators and Providing for Filling Vacancies."

Be it enacted by the Clinton County Legislature of the (Name of Legislative Body)

SECTION I.

If a vacancy occurs in the Clinton County Legislature, otherwise than by expiration of the term, the Clinton County Legislature shall fill the office within thirty (30) days of the vacancy by appointment of a resident of the District or area represented by said vacant office by at least six affirmative votes.

SECTON II.

A person appointed pursuant to Section I, to execute the duties of the office of Clinton County Legislator, shall continue until the vacancy shall be filled at the next General Election. But if the term of such legislator shall expire within the calendar year in which the appointment shall be made, the appointee shall hold said office for the residue of the term.

Section III.

Upon the failure of the County Legislature to appoint an individual to fill the vacancy within the 30 day period as described in Section I, then if the vacancy occurs more than 120 days before the next General Election there shall be a Special Election within the District or area represented by the said vacant office to be held no less than 30 days nor more than 90 days after the vacancy shall occur.

Section IV.

The date of the Special Election shall be determined by the Clinton County Legislature within the timeframe hereinbefore stated. In the event the Clinton County Legislature fails to approve a date, then the Special Election shall take place on the Tuesday preceding the ninetieth day.

Section V.

In the event that the vacancy occurs less than 120 days before the next General Election, then the vacancy shall be filled at the next General Election. The person so elected shall take office on January 1 after the General Election.

Section VI.

Local Law #5 of 1995 is hereby superseded.

Section VII.

This Local Law shall become effective upon filing with the Secretary of State.
