The Clinton County Treasurer also issues receipts for installment tax payments and delinquent tax payments.
- 3. The State Comptroller has opined that a municipality may charge a reasonable fee for the issuance of duplicate tax receipts.
- 4. The Clinton County Treasurer is hereby authorized to issue duplicates of receipts received from Collecting Officers, and receipts for installment tax payments and delinquent tax payments issued by the County Treasurer. The duplicates shall constitute proof of payment.
