#### Section 1. Title

The title of this Local Law shall be "REIMBURSEMENT FOR INMATE HEALTH CARE, CLINTON COUNTY".

#### Section 2. Purpose

The purpose of this law is to authorize the County to provide for its reimbursement for costs paid by the County, pursuant to § 500-h of the New York State Correction Law, for diagnoses, tests, studies or analyses for the diagnosis of a disease or disability, and care and treatment by a hospital, as defined in article twenty-eight of the public health law, or by a physician, or by a dentist to inmates of a local correctional facility, as is authorized by Chapter 481 of the Laws of New York.

### Section 3. Reimbursement

The County of Clinton, pursuant to § 500-h(2) of the Correction Law as the same may be amended from time to time, is hereby authorized to obtain reimbursement from any third party health insurance coverage or indemnification carried by any inmate of a Clinton County Jail facility, for the costs of any medical and dental services provided to such inmate, including diagnoses, tests, studies or analyses for the diagnosis of a disease or disability, and care and treatment by a hospital as defined in Article 28 of New York's Public Health Law, and by a physician or dentist.
