BE IT ENACTED, by the Legislature of the County of Clinton as follows:

#### **SECTION 1. NUMBER OF LEGISLATORS**

The Legislature shall consist of ten (10) members, chosen from the districts described within and apportioned among the County on the basis of the number of inhabitants of the County of Clinton in the year 1990 as set forth in this Law.

#### **SECTION 2.** NUMBER OF LEGISLATIVE DISTRICTS

There shall be ten (10) legislative districts apportioned among the County of Clinton, which are described hereafter.

(If additional space is needed, attach pages the same size as this sheet, and number each.)

#### **SECTION 3. CONSTRUCTION**

- A. This law shall be liberally construed to effectuate the purposes thereof and to apportion and district the County of Clinton in compliance with the requirements of law.
- B. It is intended that this law and the districts described herein completely encompass all the area within the County of Clinton. It is also intended that such districts, apportioned on the basis of the 1990 population, contain all the inhabitants of this County except for the institutional inmate populations of the Clinton, Lyon Mountain and Altona Correctional Facilities; and the former population residing on the Plattsburgh Air Force Base. It is further intended that the apportionment and districting provided for in this law result in the creation of districts which are substantially equal in population. It is also intended that no district shall include any of the area included within the description of any other district.

#### **SECTION 4. SAVING CLAUSE**

If the districts described in this law do not carry out the purposes thereof because of unintentional omission; duplications, overlapping areas; erroneous nomenclature; lack of adequate maps or descriptions of political subdivisions, wards, or other divisions thereof, or of their boundary lines; street closings, changes of names of streets, or other changes of public places; alteration of the boundary of or courses of waterways; filling in of lands underwater; accretion or other changes in shorelines; or alteration of courses, rights-of-way, or lines of public utilities or other conditions, then the Clinton County Board of Elections, at the request of any person aggrieved thereby or any candidate affected thereby, shall, by order, correct such omissions, overlaps, erroneous nomenclature, or other defects in description of districts so as to accomplish the purposes and objectives of this Law.

### **SECTION 5.** DESCRIPTION OF LEGISLATIVE DISTRICTS

### A. Legislative District Number One (1) shall consist of the following:

The Town of Champlain in its entirety; and

That portion of the Town of Mooers lying to the east of the boundary described as follows:

Beginning at the point where the centerline of Blackman Corners Road intersects the northern municipal boundary of the Town of Mooers, thence commencing in a southerly direction along the centerline of Blackman Corners Road to its intersection with the centerline of Pepper Hill Road, thence heading in a southwesterly direction along the centerline of Pepper Hill Road to its intersection with the centerline of State Route 11, thence heading in a southwesterly direction along the centerline of State Route 11 to its intersection with the centerline of Alder Bend Road, thence heading in a southerly direction along the centerline of Alder Bend Road to its intersection with the Town of Mooers southern municipal boundary.

### B. Legislative District Number Two (2) shall consist of the following:

The Town of Clinton in its entirety; and .

The Town of Ellenburg in its entirety; and

The Town of Dannemora in its entirety; and

That portion of the Town of Mooers lying to the west of the boundary described as follows:

Beginning at the point where the centerline of Blackman Corners Road intersects the northern municipal boundary of the Town of Mooers, thence commencing in a southerly direction along the centerline of Blackman Corners Road to its intersection with the centerline of Pepper Hill Road, thence heading in a southwesterly direction along the centerline of Pepper Hill Road to its intersection with the centerline of State Route 11, thence heading in a southwesterly direction along the centerline of State Route 11 to its intersection with the centerline of Alder Bend Road, thence heading in a southerly direction along the centerline of Alder Bend Road to its intersection with the Town of Mooers southern municipal boundary.

### C. Legislative District Number Three (3) shall consist of the following:

The Town of Chazy in its entirety; and

That portion of the Town of Beekmantown lying to the west of the boundary described as follows:

Beginning at the point where the centerline of the northbound or east lane of Interstate 87 intersects the northern boundary of the Town of Chazy, thence commencing in a southerly direction along the centerline of the northbound lane on Interstate 87, thence ending at the point where the centerline of the northbound lane intersects with the southern municipal boundary of the Town of Beekmantown.

### D. Legislative District Number Four (4) shall consist of the following:

That portion of the Town of Beekmantown lying to the east of the boundary described as follows:

Beginning at the point where the centerline of the northbound or east lane of Interstate 87 intersects the northern boundary of the Town of Chazy, thence commencing in a southerly direction along the centerline of the northbound lane on Interstate 87, thence ending at the point where the centerline of the northbound lane intersects with the southern municipal boundary of the Town of Beekmantown; also, that portion of the Town of Plattsburgh that is encompassed by the following boundary;

Beginning at the northeasternmost corner of the northern municipal boundary of the Town of Plattsburgh where said boundary intersects with the shoreline of Lake Champlain, thence commencing in a southerly direction along said shoreline around the peninsula known as Cumberland Head to the point where said shoreline intersects the City of Plattsburgh municipal boundary, thence heading in a westerly direction and following the City of Plattsburgh municipal boundary as it angles and turns to a point where said boundary intersects the centerline of Rugar Street, thence heading in a westerly direction along the centerline of Rugar Street to its intersection with the centerline of the Military Turnpike Extension, thence heading northwesterly along the centerline of the Military Turnpike Extension to its intersection with the centerline with State Route 3, thence heading westerly along the centerline of State Route 3 to its intersection with the centerline of State Route 22B, Thence heading in a westerly direction along the centerline of State Route 22B to its intersection with the centerline of Rand Hill Road, thence heading northerly along the centerline of Rand Hill Road to its intersection with the northern municipal boundary of the Town of Plattsburgh, thence heading easterly along said municipal boundary to the point of beginning.

### E. Legislative District Number Five (5) shall consist of the following:

Those portions of the Town of Plattsburgh, Town of Schuyler Falls, and Town of Peru that are encompassed by the boundary described as follows:

Beginning at a point where the centerline of State Route 22B intersects with the centerline of the Saranac River in the hamlet of Morrisonville (point located on the Route 22B bridge over Saranac River), thence commencing in an easterly direction along the centerline of State Route 22B to its intersection with the centerline of State Route 3, thence heading in an easterly direction along the centerline of State Route 3 to its intersection with the centerline of the Military Turnpike Extension, thence heading southeasterly along the Military Turnpike extension to its intersection with the centerline of Rugar Street, thence heading easterly along the centerline of Rugar Street to its intersection with the City of Plattsburgh municipal boundary, thence heading southerly along the City of Plattsburgh municipal boundary to its intersection with the centerline of the Saranac River, thence heading westerly along the centerline of the Saranac River to its intersection with the Town of Schuyler Falls eastern municipal boundary, thence heading southerly along the Town of Schuyler Falls municipal boundary as it angles and turns to its intersection with the centerline of State Route 22B, thence heading southerly along the centerline of State Route 22B to its intersection with the centerline of Brand Hollow Road, thence heading easterly along the centerline of Brand Hollow Road to its intersection with the centerline of the Military Turnpike Extension, thence heading southerly along the centerline of the Military Turnpike Extension to its intersection with the centerline of State Route 22, thence heading in a southwesterly direction along the centerline of State Route 22 to its intersection with the centerline of Arnold Brook, thence heading easterly along the centerline of Arnold Brook to its intersection with the centerline of the Little Ausable River, thence heading southwesterly along the centerline of

the Little Ausable River to its intersection with the centerline of Jarvis Road, thence heading northerly along the centerline of Jarvis Road to its intersection with River Road, thence heading westerly along the centerline of River Road to its intersection with the Barney Downs Road, thence heading westerly along the centerline of the Barney Downs Road to its intersection with the centerline of Old Town Road, thence heading northerly along the centerline of the Old Town Road to its intersection with the centerline of Mannix Road, thence heading westerly along the centerline of Mannix Road to its intersection with the centerline of Clark Road, thence heading northerly along the centerline of Clark Road to its intersection with the centerline of Peasleeville Road, thence heading westerly along the centerline of Peasleeville Road to its intersection with the centerline of Conners Road, thence heading northerly along the centerline of Conners Road to its intersection with the Town of Schuyler Falls southern municipal boundary, thence heading westerly and following the Town of Schuyler Falls municipal boundary as it angles and turns northerly to its intersection with the centerline of Hardscrabble Road, thence heading easterly along the centerline of Hardscrabble Road to its intersection with the centerline of Flat Rock Road, thence heading easterly along the centerline of Flat Rock Road to its intersection with a high voltage powerline located to the east of Vassar Road, thence heading northerly along said high voltage powerline to its intersection with the centerline of Sand Road, Thence heading easterly along the centerline of Sand Road to its intersection with the centerline of State Route 22B, thence heading northerly along the shortest line possible to the centerline of the Saranac River, which is also the Town of Schuyler Falls northern municipal boundary, thence heading easterly along the centerline of the Saranac River as it winds and turns to the point of beginning.

### F. Legislative District Number Six (6) shall consist of the following:

The Town of Saranac in its entirety; and

The Town of Black Brook in its entirety; and

Those portions of the Town of Plattsburgh and Town of Schuyler Falls encompassed by the boundary described as follows:

Beginning at the northeasternmost corner of the Town of Saranac municipal boundary, which is also the northwesternmost corner of the Town of Plattsburgh municipal boundary, thence commencing in an easterly direction along the Town of Plattsburgh municipal boundary to its intersection with the centerline of Rand Hill Road, thence heading southerly along the centerline of Rand Hill Road to its intersection with the centerline of State Route 22B, thence heading westerly along the centerline of State Route 22B to its intersection with the centerline of the Saranac River (point located on the Route 22B bridge over the Saranac River), thence heading westerly along the centerline of the Saranac River (which is also a southern municipal boundary of the Town of Plattsburgh) to a point along said centerline that is the shortest distance from the point described as the intersection of the centerlines of State Route 22B and Sand Road, thence heading southerly along a straight line that would connect to the point that is the intersection of the centerlines of State Route 22B and Sand Road, thence heading southwesterly along the centerline of Sand Road to its intersection with a high voltage powerline located east of Vassar Road, thence heading southerly along said high

voltage powerline to its intersection with the centerline of Flat Rock Road, thence heading westerly along the centerline of Flat Rock Road to its intersection with the centerline of Hardscrabble Road, thence heading westerly along the centerline of Hardscrabble Road to its intersection with the eastern municipal boundary of the Town of Saranac, thence heading northerly along said Town of Saranac municipal boundary to the point of beginning.

### G. Legislative District Number Seven (7) shall consist of the following:

The Town of Ausable in its entirety; and

All of the Town of Peru except for that section that is encompassed by the boundary that is described as follows;

Beginning at the intersection of the centerline of State Route 22B and the northern municipal boundary of the Town of Peru, thence commencing southerly along the centerline of State Route 22B to its intersection with the centerline of Brand Hollow Road, thence heading easterly along the centerline of Brand Hollow Road to its intersection with the centerline of the Military Turnpike Extension, thence heading southerly along the centerline of the Military Turnpike Extension to its intersection with the centerline of State Route 22, thence heading in a southwesterly direction along the centerline of State Route 22 to its intersection with the centerline of Arnold Brook, thence heading easterly along the centerline of Arnold Brook to its intersection with the centerline of the Little Ausable River, thence heading southwesterly along the centerline of the Little Ausable River to its intersection with the centerline of Jarvis Road, thence heading northerly along the centerline of Jarvis Road to its intersection with River Road, thence heading westerly along the centerline of River Road to its intersection with the Barney Downs Road, thence heading westerly along the centerline of the Barney Downs Road to its intersection with the centerline of Old Town Road, thence heading northerly along the centerline of the Old Town Road to its intersection with the centerline of Mannix Road, thence heading westerly along the centerline of Mannix Road to its intersection with the centerline of Clark Road, thence heading northerly along the centerline of Clark Road to its intersection with the centerline of Peasleeville Road, thence heading westerly along the centerline of Peasleeville Road to its intersection with the centerline of Conners Road, thence heading northerly along the centerline of Conners Road to its intersection with the Town of Peru northern municipal boundary, thence heading easterly along the Town of Peru municipal boundary to the point of beginning.

### H. Legislative District Eight (8) shall consist of the following:

Those portions of the Town of Plattsburgh and City of Plattsburgh which are encompassed by the following boundary;

Beginning at a point which is the intersection of the centerline of the Saranac River and Bridge Street (located on the Bridge Street bridge), thence commencing northeasterly along the centerline of the Saranac River to its intersection with the shoreline of Lake Champlain

(mouth of the Saranac River), thence heading southerly along the Lake Champlain shoreline as it winds and turns to its intersection with the southern boundary of the Town of Plattsburgh, thence heading westerly along the Town of Plattsburgh municipal boundary as it angles and turns to its intersection with the centerline of the Saranac River (point located in the Treadwell Mills area), thence heading easterly along the centerline of the Saranac River to its intersection with a northerly extension of the centerline of the north-south portion of Sandlewood Way, thence heading southerly along said extension of Sandlewood Way to its intersection with the centerline of Sandlewood Way, thence continuing southerly along the centerline of Sandlewood Way to its intersection with the centerline of Underwood Avenue, thence heading easterly along the centerline of Underwood Avenue to its intersection with the centerline of South Catherine Street, thence heading northeasterly along the centerline of South Catherine Street to its intersection with the centerline of Monty Street, thence heading easterly along the centerline of Monty Street to its intersection with the centerline of South Peru Street, thence heading northeasterly along the centerline of South Peru Street to its intersection with the property line of the former Plattsburgh Air Force Base, thence heading westerly along said property line to its intersection with the centerline of the Saranac River, thence heading southwesterly along the centerline of the Saranac River to a point where a southerly extension of the centerline of Walworth Street intersects the centerline of the Saranac River, thence heading northerly along said extension of the centerline of Walworth Street to its intersection with the centerline of Walworth Street, thence heading northerly along the centerline Walworth Street to its intersection with the centerline of Battery Street, thence heading westerly along the centerline of Battery Street to its intersection with the centerline of South Catherine Street, thence heading southerly along the centerline of South Catherine Street to its intersection with the centerline of Goff Avenue, thence heading westerly along the centerline of Goff Avenue to its intersection with the centerline of Steltzer Road, thence heading westerly along the centerline of Steltzer Road to its intersection with the centerline of Broad Street, thence heading westerly along the centerline of Broad Street to its intersection with the centerline of William Street, thence heading northerly along the centerline of William Street to its intersection with the centerline of Cornelia Street, thence heading easterly along the centerline of Cornelia Street to its intersection with the centerline of City Hall Place, thence heading southerly along the centerline of City Hall Place to its intersection with the centerline of Bridge Street, thence heading easterly along the centerline of Bridge Street to the point of beginning.

### I. Legislative District Number Nine (9) shall consist of the following:

that portion of the City of Plattsburgh encompassed by the following boundary:

Beginning at a point which is the intersection of the centerlines of Cornelia Street and Williams Street, thence commencing southerly along the centerline of Williams Street to its intersection with the centerline of Broad Street, thence heading easterly along the centerline of Broad Street to its intersection with the centerline of Steltzer Avenue, thence heading southerly along the centerline of Steltzer Avenue to its intersection with the centerline of Goff Avenue to its intersection with the centerline of South Catherine Street, thence heading northerly along the centerline of South Catherine Street to its intersection with the centerline of Battery Street, thence heading

easterly along the centerline of Battery Street to its intersection with the centerline of Walworth Street, thence heading southerly along the centerline of Walworth Street, and continuing southerly along a southerly extension of the centerline of Walworth Street to its intersection with the centerline of the Saranac River, thence heading northeasterly along the centerline of the Saranac River to its intersection with the property line of the Former Plattsburgh Air Force Base, thence heading easterly along the property line of the Plattsburgh Air Force Base to its intersection with the centerline of South Peru Street, thence heading southerly along the centerline of South Peru Street to its intersection with the centerline of Monty Street, thence heading westerly along the centerline of Monty Street to its intersection with the centerline of South Catherine Street, thence heading southwesterly along the centerline of South Catherine Street to its intersection with the centerline of Underwood Avenue, thence heading westerly along the centerline of Underwood Avenue to its intersection with the centerline of Sandlewood Way, thence heading northerly along the centerline of Sandlewood Way, and continuing northerly along a northerly extension of the centerline of Sandlewood Way to its intersection with the centerline of the Saranac River, thence heading southwesterly along the centerline of the Saranac River to a point that is the corner of the western municipal boundary and southern municipal boundary of the City of Plattsburgh, thence heading northerly along the municipal boundary of the City of Plattsburgh as it angles and turns, to its intersection with the centerline of Cornelia Street. thence heading easterly along the centerline of Cornelia Street to the point of beginning.

### J. Legislative District Number Ten (10) shall consist of the following:

that portion of the City of Plattsburgh encompassed by the following boundary:

Beginning at a point in the northeasternmost corner of the City of Plattsburgh municipal boundary, which is located on the shoreline of Lake Champlain, thence commencing in a southwesterly direction along the shoreline of Lake Champlain to its intersection with the centerline of the mouth of the Saranac River, thence heading westerly (upstream) along the centerline of the Saranac River to its intersection with the centerline of Bridge Street (located on the Bridge Street Bridge), thence heading westerly along the centerline of Bridge Street to its intersection with the centerline of City Hall Place, thence heading northerly along the centerline of City Hall Place to its intersection with the centerline of Cornelia Street, thence heading westerly along the centerline of Cornelia Street to its intersection with the western City of Plattsburgh municipal boundary, thence heading northerly and following the City of Plattsburgh municipal boundary as it angles and turns to the point of beginning.

#### **SECTION 6. PERMISSIVE REFERENDUM**

This Law shall be subject to permissive referendum pursuant to Section 24 of the Municipal Home Rule Law and Section 101 of the County Law and shall take effect immediately as provided by said sections.

#### **SECTION 7. MAPS OF THE DISTRICTS**





#### ATTACHMENT D

#### EXPLANATION OF ALLOCATION OF POPULATION FOR LEGISLATIVE DISTRICTS

Reapportionment of Clinton County Legislative Districts is based on the 1990 U.S. Bureau of Census population figures for the municipalities of Clinton County, less the combined institutional population of Clinton, Lyon Mountain, and Altona Correctional Facilities (3,569 persons); and less the population of the former Plattsburgh Air Force Base (6,689 persons), which closed in 1995. Therefore, the population utilized for purposes of redistricting as presented in this Local Law is determined as follows:

Total 1990 Population of Clinton County:	85,969
minus population of Correctional Facilities	-3,569
minus population of Plattsburgh Air Force Base	<u>-6,689</u>

In apportioning the Clinton County population of 75,711 equally among the ten (10) legislative districts, the average population for each district (7,571) was determined by dividing the total population (75,711) by the number of legislative districts in the County (10).

In order to achieve "substantially equal weight" for all the voters of the County, each legislative district was allowed a population variation of no more than five (5) percent of the average population for each district, as follows:

Five percent of the average population for each district = 7,571 X .05 = 378.55 (Since a portion of a person is not practicable, the number is rounded up to 379.

To determine the lower limit for a 5% deviation from average, 379 is subtracted from the average population for each district: 7,571 - 379 = 7,192

To determine the upper limit for a 5% deviation from average, 379 is added to the average population for each district: 7,571 + 379 = 7,950

Therefore, each legislative district shall contain a population between 7,192 and 7,950 in order to be within 5% of the average population for each district.
