The said Council shall have the authority to expend such funds as it may have in its possession, or appropriated to it and for purposes appropriated thereto.

the Band of the said Council shall have the power to fix the amount of the Band of the said fiscal officer, and to obtain Public Liability insurance to protect the activities of the Council, its members, officers, applicates, or servants.
