NOTICE IS HEREBY GIVEN, that there has been introduced before the Legislature of the County of Clinton, New York on the 13thday of November, 1985, a Local Law Number 5 of the year 1985 entitled: "LOCAL LAW ESTABLISHING SALARIES IN THE OFFICE OF COUNTY CLERK, SHERIFF AND COUNTY TREASURER, WHICH PROVIDES:

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF CLINTON AS FOLLOWS: SECTION I: Legislative Intent:

The County of Clinton, heretoforehaving recognized the increasing complexity of County Government
and the necessity to adequately compensate its re-elected
officials in the offices of County Clerk, Sheriff and County
Treasurer. It also recognizing these elected officials are
department heads and that their salaries are not commensurate
with other county department heads, having similar responsibilities.

SECTION II: County Clerk:

The salary of the County Clerk for the year 1986 shall be \$25,000.00.

SECTION III: County Sheriff:

The salary for the County Sheriff

shall be \$25,000.00 for the year 1986.

SECTION IV: County Treasurer:

The salary for the County Treasurer

shall be \$25,000.00 for the year 1986.

SECTION V: Salaries for Subsequent Years:

The salaries for the subsequent years of the office of County Clerk, County Sheriff and County Treasurer shall not be increased subsequent years unless such increases are applied equally to each office.

SECTION VI: Effective Date:

The effective date of this Local Law shall be the first day of January, 1986.
