A local law To Provide A Real Property Tax Exemption to Persons

With Disabilities Who Have Limited Incomes Pursuant to
Section 459-c of the Real Property Tax Law

- The purpose of this law is to provide an exemption from real property taxes in accordance with and subject to the provisions of Section 459-c of the Real Property Tax Law (Persons With Disabilities and Limited Incomes).
- Individuals who qualify under the provisions of Section 459-c of the Real Property Tax Law shall receive a real property tax exemption to the extent provided in the following schedule:

<u>ANNUAL INCOME</u>	<u>PERCENTAGE OF ASSESSED VALUATION EXEMPT FROM TAXATION</u>
Up to \$18,500	50 per centum
More than \$18,500, but less than \$19,000	45 per centum
\$19,000 or more, but less than \$20,500	40 per centum
\$20,500 or more, but less than \$21,500	35 per centum
\$21,500 or more, but less than \$22,400	30 per centum
\$22,400 or more, but less than \$23,300	25 per centum
\$23,300 or more, but less than \$24,200	20 per centum
\$24,200 or more, but less than \$25,100	15 per centum
\$25,100 or more, but less than \$26,000	10 per centum
\$26,000 or more, but less than \$26,900	5 per centum
