- Local Law No. 4 of the year 1997 was passed "Repealing Local Law No. 2 of 1984 entitled, "Alternative Veterans Exemption Option to Not Grant Exemption."
- By repealing Local Law No. 2 of 1984, Local Law No. 4 of 1997 allowed an exemption from real property taxes to the provisions outlined in Real Property Tax Law Section 458(a) - Alternative Veterans Exemption.
- Local Law No. 4 of 1997 set the exemption limits to the State Law Maximums as follows:

Wartime Veteran	15% of assessed value to a maximum of \$12,000
Combat Zone Veteran	10% of assessed value to a maximum of \$8,000
Disabled Veteran	50% of disability rating to a maximum of \$40,000
- Real Property Tax Law Section 458(a) further allowed that by a local law maximums could be increased as follows:

Wartime Veteran	15% of assessed value to a maximum of \$15,000, \$18,000, \$21,000 \$24,000 or \$27,000
