A Local Law Repealing Local Law No. 3 of the Year 1996 Thereby Eliminating Term Limits  
for Members of the Clinton County Legislature

**BE IT ENACTED** by the Legislature of the County of Clinton, State of New York, as follows:

**Section 1.** Whereas, Local Law No. 3 of the year 1996 imposed limitations on the consecutive terms to be held by member(s) of the Clinton County Legislature to be computed in accordance with said Local Law.

**Section 2.** Now, it is determined that a Local Law be adopted which will allow the qualified electors of the County of Clinton to vote on the issue of whether to effectively repeal and rescind Local Law No. 3 of the year 1996 thereby eliminating any limit upon the number of consecutive terms any member of the Clinton County Legislature may serve.

**Section 3.** It is therefore the intent of the within Local Law to repeal Local Law No. 3 of the year 1996 thereby eliminating any limit upon the number of consecutive terms that may be held by any member of the Clinton County Legislature.

**Section 4. Effective Date.** This law shall be submitted for the approval of the electors of the County of Clinton at the next general election to be held on the 2<sup>nd</sup> day of November, 2010. If this law is approved by the affirmative vote of the majority of the qualified electors of the County voting thereon at such general election, this law shall be effective immediately upon filing with the office of the Secretary of State.




