SECTION 1. Pursuant to Article 6 of the County Law there is hereby established an enhanced emergency telephone system surcharge - local surcharge, for the purpose of partially funding an E911 System to be established in the County of Clinton.

SECTION 2. Such surcharge shall be in the amount of Thirty-Five Cents (35¢) per access line per month and the customers of every service supplier within Clinton County, and each such service supplier shall commence billing for same at the earliest time permitted by law.

SECTION 3. Such surcharge shall have uniform application and shall be imposed throughout the entire county to the greatest extent possible in conformance with the availability of such E911 System within the County.

SECTION 4. No such surcharge shall be imposed upon more than seventy-five (75) access lines per customer per location.

SECTION 5. Lifeline customers and the County shall be exempt from any surcharge imposed under this Article.
