as follows:

1. The purpose of this law is to increase the maximum income ceiling from \$18,500 to \$19,500 for the partial real property tax exemption for property owned by senior citizens 65 years of age and older who meet certain income limitations and other requirements as set forth in Section 467 of the Real Property Tax Law, as amended by Chapter 298 of the Laws of 1998.
2. This increase will apply to assessment rolls based on taxable status dates on or after January 1, 1999 and this Local Law will supersede Local Law No. 2 of 1996.
3. The increase is necessary to protect our senior citizens on fixed incomes from their ever-increasing local real property tax burden. Such increases are also necessary so that cost of living adjustments in social security do not make currently qualifying senior citizens ineligible for the exemption.
4. This local law shall take effect immediately.


