Legislator Timmons motioned to exit Executive Session at 6:05 p.m., seconded by Legislator Waldron. Carried (9-0-1).

There being no further business to come before the Legislature, Legislator Hughes motioned to adjourn the meeting at 6:05 p.m., seconded by Legislator Bezio. Carried (9-0-1).
