Following the pledge of allegiance, Mr. Zurlo called upon John Zurlo, the County Clerk, to administer the oath of office to all newly-elected Legislators and invited them to sign the book of oaths.

Deputy County Administrator Rodney Brown conducted roll call. All Legislators were present.

Mr. Brown read the title of Resolution #1, "Appointing Chairperson of the County Legislature for 2018."

Legislator Waldron offered by name of Harry J. McManus to be appointed as Chairperson of the Clinton County Legislature for 2018. She stated it was with complete confidence she would like to nominate Legislator Harry McManus to once again be Chairperson in 2018. Resolution #4, "Appointing Minority Leader of the Clinton County Legislature for 2018." Legislator Dame motioned to offer the name of Jonathan Beach as Minority Leader for the year 2018, seconded by Legislator Timmons. Carried (9-0-0-1). (Vacancy, Area 3).

Resolution #5, "Adopting Rules of Order for 2018" was adopted by a vote of 5/4. Carried (9-0-0-1). (Vacancy, Area 3).

Resolution #6, "Appointing County Attorney for the Years 2018 and 2019." Legislator Keenan motioned to offer the name of James Coffey, Esq., seconded by Legislator Waldron. Carried (9-0-0-1). (Vacancy, Area 3).

Resolution #7, "Appointing Assistant County Attorney for the Year 2018." Legislator Conroy motioned to offer the name of Gary Favro, Esq., seconded by Legislator Rosenquest. Carried (9-0-0-1). (Vacancy, Area 3).

Resolution #8, "Appointing Administrator of Indigent Defendants for 2018." Legislator Hall motioned to offer the name of Justin Meyer, Esq. as Administrator of Indigent Defendants for 2018." Legislators Waldron, Rosenquest and Beach seconded the motion. Carried (9-0-0-1). (Vacancy, Area 3).
