# December 16, 2022

Stenographer's minutes of the Regular Session of the Clinton County Legislature held Wednesday, December 14, 2022 in the Legislative Chambers, 137 Margaret Street, Plattsburgh, New York.

The meeting included remote access via teleconference in accordance with Local Law #1 of 2022. Legislator Hughes attended via Zoom.

Chairperson Henry called the meeting to order at 5:15 p.m.

Michael Zurlo, the County Administrator, conducted roll call.

Legislator Hall motioned to accept the minutes of the November 21, 2022 Regular Session, seconded by Legislator Kretser. Carried (10-0-0).

Chairperson Henry invited Mr. Zurlo to the podium to present a special award. Chairperson Henry stated the Clinton County Legislature would like to formally recognize Mr. Joseph Musso for his years of service to the Civil Service Employees Association (CSEA). Mr. Zurlo stated it is an honor to present Mr. Musso with this award. Mr. Zurlo read the title of Resolution #909 titled, "Congratulating Joseph F. Musso on his Exemplary Service with the Civil Service Employees Association, Inc." Mr. Zurlo read Resolution #909 to the attendees and presented Mr. Musso with a plaque. Mr. Musso stated it is an honor and privilege to receive this award and he was fortunate to represent several thousands of County employees throughout the years. Mr. Musso thanked his friends, family and colleagues for this recognition.

Chairperson Henry asked if anyone wished to address the Legislature.

There being no one else to address the Legislature, Chairperson Henry moved on to Committee Reports.

Legislator Bezio reported the Buildings and Grounds Committee scheduled for Monday, December 12th was cancelled.

## Children and Family Services Committee - Legislator Potiker

Legislator Potiker reported the Children and Family Services Committee met on Tuesday, December 6th.

John Redden, the Commissioner of Social Services, and Christine Peters, the Director of Legal/Social Services, were present to discuss several resolutions including, "Authorizing Contract with Fatherhood Connection, Inc.," "Authorizing Memorandum of Understanding (MOU) with Champlain Valley Family Center" and "Authorizing Memorandum of Understanding (MOU) with Clinton County Mental Health and Addiction Services."

## County Attorney - Jacqueline Kelleher, Esq.

Ms. Kelleher did not have a report.

## County Administrator - Michael Zurlo

Mr. Zurlo asked the Legislature to advise on their attendance for the upcoming New York State Association of Counties (NYSAC) Legislative Conference taking place from February 27th through March 1, 2023.

Mr. Zurlo also requested an Executive Session to discuss a matter of collective negotiations.

# **Chairpersons Report**

Chairperson Henry noted his email to the Legislature regarding the dinner for the January 4<sup>th</sup> Organizational Meeting and advised those that hadn't responded to please do so.

There being no further business, Chairperson Henry moved on to resolutions. The following resolutions were approved unless otherwise noted.

Resolutions #912 through #924 were approved.

Resolution #925 titled, "Authorizing Contract with the Town of Plattsburgh for Assisted Assessing Services" was motioned by Legislator Waldron and seconded by Legislator Potiker. Carried (10-0-0).

Discussion: Mr. Zurlo noted Kim Kinblom, the Deputy County Administrator, was present at the Economic Development and County Operations Committee meeting held earlier and shared the status of the 2022 Shared Services Plan that contains three items. This resolution is for one of the items. The second is for the joint purchase of the new Computer-Aided Dispatch (CAD) System between Clinton, Essex and Franklin Counties, resulting in a savings of approximately \$380,000 in year one and over the life of the contract, nearly \$1 million in savings. The third item is the Town of Peru and the Town of AuSable purchasing a piece of highway equipment together. Mr. Zurlo noted Public Hearing #1 was held today, the second will be held on Thursday, December 15th and the third will be held on Friday, December 16th. The Shared Services panel will then convene to vote on the Shared Services Plan on December 22, 2022.

Resolutions #926 through #956 were approved.

Resolution #957 titled, "Authorizing Contract with Jennifer Facteau-Rabideau, N.P." was motioned by Legislator Castine and seconded by Legislator Hughes. Carried (9-0-0-1).

Discussion: Legislator Peryea abstained.

Resolutions #958 through #961 were approved.

Resolution #962 titled, "Authorizing Contract with Tyler Technologies Public Safety Division" was motioned by Legislator Castine and seconded by Legislator Hall. Carried (10-0-0).

Discussion: Mr. Zurlo stated this is another piece of the Shared Services Plan. This is a five-year contract resulting in savings of approximately \$900,000.

Resolutions #963 through #972 were approved.

Resolution #973 titled, "Authorizing the County Treasurer to Adjust Appropriation and Corresponding Revenue for the Workforce Investment Act Grant" was motioned by Legislator Timmons and seconded by Legislator Peryea. Carried (9-0-0-1).

Discussion: Legislator Kretser abstained.

Resolution #974 titled, "Authorizing the County Treasurer to Adjust Appropriation and Corresponding Revenue for the Workforce Investment Act Grant" was motioned by Legislator Timmons and seconded by Legislator Castine. Carried (9-0-0-1).

Discussion: Legislator Kretser abstained.

Resolutions #975 through #978 were approved.

Resolution #979 titled, "Authorizing the County Treasurer to Landfill Revenue to the General Fund" was motioned by Legislator Timmons and seconded by Legislator Castine. Carried (10-0-0).

Discussion: Mr. Zurlo stated this resolution allows for the revenue from the sale of methane gas into the budget.

Resolutions #980 and #981 were approved.

Resolution #982 has been withdrawn.

Legislator Waldron motioned to Waive Rule 13.2, seconded by Legislator Hughes. Carried (10-0-0).

Resolution #983 titled, "Authorizing the County Treasurer to Establish Appropriation and Corresponding Revenue for the Absentee Ballot Prepaid Postage Grant" was motioned by Legislator Waldron and seconded by Legislator Kretser. Carried (10-0-0).

Discussion: Mr. Zurlo stated this resolution is for the Board of Elections to expend grant funds by the end of the year.

Legislator Castine thanked Mr. Zurlo, his staff and the Department Heads for the budget they presented to the Legislature. Mr. Castine noted the County was able to help employees this year financially and have a very manageable budget. Mr. Zurlo responded by thanking Ms. Kinblom and Lee Mitchell, the County Accountant, for the work they put in and to provide a budget comfortable representing their constituents.

Mr. Zurlo thanked David Randall, the Director of Information Technology, for his efforts to facilitate live-streaming the meeting and noted he will be back for the December 28th Regular Session as well.

Legislator Hall motioned to enter Executive Session at 6:03 p.m., seconded by Legislator Peryea. Carried (10-0-0).

Legislator Hughes motioned to exit Executive Session at 6:31 p.m., seconded by Legislator Hall. Carried (10-0-0).

Resolution #984 was approved.

There being no further business to come before the Legislature, Legislator Hall motioned to adjourn the meeting at 6:32 p.m., seconded by Legislator Timmons. Carried (10-0-0).
