Stenographer's minutes of the Regular Session of the Clinton County Legislature held Wednesday, March 12, 2025 in the Legislative Chambers, 137 Margaret Street, Plattsburgh, New York.

Chairperson Henry called the meeting to order at 5:17 p.m.

Michael Zurlo, the County Administrator, conducted roll call. Legislator Peryea asked to be excused.

Legislator Kretser motioned to accept the minutes of the February 26, 2025 Regular Session, seconded by Legislator Bezio. Carried (9-0-1).

Chairperson Henry asked if anyone wished to address the Legislature.

Chairperson Henry stated the topic of the dog tether law would not be discussed since there is no legislation and the Legislature has heard the position on the law several times, including a few days ago, and for tonight, the Legislature will not be granting the topic of the dog tether law the privilege of the floor.

Jessica Murnane, of Morrisonville, New York, asked to speak on the transparency and accountability of the Legislature. She stated she has been involved for a short period of time in local meetings. She stated Clinton County is an amazing County and has a lot of privileges. She is concerned about the lack of clear understanding as to what the process is if there is a concerned citizen in their area, how does she know when the topic is being discussed. Ms. Murnane stated whether the law is protecting animals or humans it needs to make sense. Her concern is a lack of a clear understanding of a process. Ms. Murnane stated a public hearing should be, come one, come all.

Jennifer Jewett, of Champlain, New York, asked to address the Legislature regarding the First Amendment and Open Meetings Law. Chairperson Henry said that would not be discussed.

After an outburst from the crowd stating it was unfair Ms. Jewett was not allowed to speak, Legislator Hall stated he doesn't believe it is right to not allow someone to speak. He stated the public should be able to tell him what is going on and what has happened tonight is totally wrong. Legislator Hall stated himself and Ms. Waldron are working hard to get a public hearing on the proposed dog tether law. He stated some of his colleagues do not agree with what Ms. Jewett and all are trying to do and there is nothing wrong with that. At the same time, Ms. Jewett and all have a right to have a public hearing. He noted it is not going to solve anything repeatedly talking about the dog tether law. He asked Ms. Jewett and all to give himself and Legislator Waldron a chance to get enough votes and they will fight like hell to get a public hearing.

There being no one else who wished to address the Legislature, Chairperson Henry moved onto the Committee Reports.

Buildings and Grounds Committee – Legislator Lamoy

Legislator Lamoy stated the Buildings and Grounds Committee met on Tuesday, March 11th.

Superintendent James Cleveland was present to discuss the Highway Garage Ventilation System Project, the Highway Garage Roof Project, the Master Plan and an update on the American Rescue Plan Act.

Children and Family Services Committee - County Administrator Michael Zurlo
