Chairperson Henry called the meeting to order at 5:15 p.m.

Michael Zurlo, the County Administrator, conducted roll call. Legislator Peryea asked to be excused.

Legislator Hall motioned to accept the minutes of the September 22, 2021 Regular Session, seconded by Legislator Timmons. Carried (8-0-1-1).

Chairperson Henry asked if anyone wished to address the Legislature.

There being no one who wished to address the Legislature, Chairperson Henry moved on to Committee Reports.

## Buildings and Grounds Committee - Legislator Timmons

Legislator Timmons reported the Buildings and Grounds Committee has not met since the last Regular Session.

The Committee was polled on Resolution #719 on the agenda.

James Cleveland, the Superintendent of the Buildings and Grounds Department, stated the northeast side of the Roof Replacement Project has been completed and the portion near the employee parking lot is now underway. Completion is expected within a few weeks with weather permitting.

The next Buildings and Grounds Committee meeting is tentatively scheduled for Monday, October 18th at 4:30 p.m.

## Children and Family Services Committee - Legislator Potiker

Legislator Potiker reported the Children and Family Services Committee met on Tuesday, October 5th. John Redden, the Commissioner of Social Services, was present to discuss two resolutions, along with the Home Energy Assistance Program (HEAP) and the Emergency Rental Assistance Program (ERAP).

Resolutions #720 and #721 have been placed on the agenda.

# Economic Development and County Operations Committee - Legislator Waldron

Legislator Waldron reported the Economic Development and County Operations Committee met earlier. John Zurlo, the County Clerk, was present to discuss a resolution, "Authorizing Contract with Cott Systems" and the status of the Department's 2021 Budget and request to increase appropriation and corresponding revenue.

David Randall, the Director of Information Technology, was also in attendance to discuss two resolutions including, "Authorizing Contract Extension with the New York State Division of Homeland Security and Emergency Services." Mr. Randall also spoke about multi-factor authentication requirements for the 2022 Cyber Insurance Renewal.

## Finance Committee - Legislator Timmons

Kimberly Davis, the County Treasurer, was present to discuss several resolutions, along with sales tax and the 2020 Fiscal Stress Report.

Kim Kinblom, the Deputy County Administrator, discussed the updated draft Title VI Plan that was submitted to the New York State Department of Transportation (NYSDOT) for approval.

#### Health Committee - Legislator Hughes

Legislator Hughes stated the Health Committee met on Wednesday, October 6th.

John Kanoza, the Director of Public Health, provided an update on COVID-19 cases and vaccinations. There are currently 236 active cases in isolation, with 25 being hospitalized at CVPH. Of those in the hospital, 68 percent are unvaccinated.

The County Health Department will be moving their vaccination clinic held on Thursdays to Clinton Community College to accommodate the increase in clients for booster shots. Testing will continue to be offered at the Health Department on Monday's, Wednesday's and Friday's for those without primary care or insurance.

School testing is underway, with 334 test samples being collected last week. There has been discussion of having a central testing site at Champlain Valley Educational Services (CVES) for those who are asymptomatic and missed the testing opportunity at their individual school.

Resolution #732 has been placed on the agenda.

The next Health Committee meeting is tentatively scheduled for Wednesday, November 3<sup>rd</sup> at 4:15 p.m.

## Human Services Committee - County Administrator Michael Zurlo

Mr. Zurlo reported the Human Services Committee met on Tuesday, October 5th.

Jody Mercaldi, the Administrative Assistant at Office for the Aging, was present to discuss three resolutions, including "Authorizing the Purchasing Agent to solicit Request for Proposals (RFPs) for Personal Care Level 1 and Chore Companion Services."

Kevin LeBoeuf, the Director of Veterans' Service Agency, was present to discuss the monthly statistics for September, 2021, filling the vacancy of a Veterans Service Officer and Operation Green Light.

#### County Attorney - Jacqueline Kelleher, Esq.

## County Administrator - Michael Zurlo

Mr. Zurlo stated department budget meetings are continuing. The New York State Attorney General Letitia James was recently in Plattsburgh to present the County with an opioid settlement check. Mr. Zurlo also spoke about the exciting news regarding the border re-opening to fully-vaccinated individuals.

Mr. Zurlo noted the resolution on the agenda to change two Regular Session meetings due to the Thanksgiving holiday and the County budget timeline. Mr. Zurlo stated he would also like to request an Executive Session to discuss the sale and lease of real property.

#### Chairperson's Report - Legislator Henry

Chairperson Henry did not have a report.

There being no further business, Chairperson Henry moved on to resolutions. The following resolutions were approved unless otherwise noted.

Resolutions #717 through #730 were approved.

Resolution #731 titled, "Authorizing the County Treasurer to Transfer Appropriation from the Contingency Budget" was moved by Legislator Timmons and seconded by Legislator Waldron. Carried (8-0-1-1).

Discussion: Mr. Zurlo stated he fully expects the money to be paid back to the County for the Flextech Program and this is simply a cash flow issue to pay the contractor.

Resolutions #732 through #758 were approved.

Resolution #759 titled, "Authorizing 2020 Statewide Interoperability Communications Formula-Based Grant Acceptance" was moved by Legislator Castine and seconded by Legislator Waldron. Carried (8-0-1-1).

Discussion: Mr. Zurlo stated this Grant pays for the lease payments on the new radio system.

Resolutions #760 through #773 were approved.

Legislator Kretser motioned to Waive Rule 13.2, seconded by Legislator Hughes. Carried (8-0-1-1).

Legislator Hall motioned to enter into Executive Session at 5:54 p.m., seconded by Legislator Hughes. Carried (8-0-1-1).

Legislator Hall motioned to exit Executive Session at 6:31 p.m., seconded by Legislator Waldron. Carried (8-0-1-1).

There being no further business to come before the Legislature, Legislator Hall motioned to adjourn the meeting at 6:32 p.m., seconded by Legislator Hughes. Carried (8-0-1-1).
