Stenographer's minutes of the Regular Session of the Clinton County Legislature held Wednesday, September 26, 2018 in the Legislative Chambers, 137 Margaret Street, Plattsburgh, New York.

James Coffey, Esq., County Attorney Melody Lemieux, Principal Stenographer Chairperson McManus called the meeting to order at 7:00 p.m.

Following the pledge of allegiance to the flag, County Administrator Michael Zurlo conducted roll call. Legislator Rosenquest was excused. Legislator Beach was in route to the meeting.

Legislator Hall motioned to accept the minutes of the September 12, 2018 Regular Session, seconded by Legislator Conroy. Carried (8-0-2).

Chairperson McManus asked if anyone wished to address the Legislature.

Geoffrey Barker addressed the Legislature. After reading past minutes of the County Legislature's Regular Sessions, he complimented Legislator Conroy for recognizing Volo Aviation as the best Fixed Base Operator (FBO) for anticipated growth at Plattsburgh International Airport. However, the selection was made for a new startup FBO as it would "keep the County's best interest in mind." He stated there is an understanding among many people in the aviation community that the bid was awarded using wrongfully-obtained data that prejudiced Volo Aviation and gave an unfair advantage to the selected Fixed Base Operator. He feels the two current FBO contracts should be rescinded and consolidated as a single contact back to Volo Aviation. In the Essential Air Service Contract rules and regulations, the Airport is in a binding contract to have SkyWest fly 12 flights per week using the aircraft of no more than a 50 passenger seat capacity. No other medium hub airline can serve this airport. If any of the rules are broken, then the \$3.3 million Essential Air Subsidy will be lost. Mr. Barker stated with regards to Tailwinds Restaurant at the Airport, he feels it is unfair to have an arbitrary utility rate. He also feels it is unfair to accept Canadian money at par at the restaurant. He feels the small concession stand that is there now is a good option and should be continued. He asked the Legislature to cut costs and taxes, and spend within means.

Kimberly Davis, the County Treasurer, addressed the Legislature regarding the State Comptroller's recent determination of Clinton County being under "susceptible to fiscal stress designation." She reported in the past two years, Clinton County has had no designation which is the best score that counties can get (that score is 0-44). She reported this year, Clinton County's score was 45. Ms. Davis explained this was anticipated due to cash flow for the Governor's Upstate Airport Initiative Projects. She explained the County lays out the funding for the projects and is later reimbursed. She explained the Comptroller's Office only looks at the General Fund, it does not look at any Reserves or any other available funds. She anticipates a similar score next year or a slight improvement. This score does not affect the county finances or the budget. Reserves are healthy. Ms. Davis reported we could have borrowed the funds to keep our fiscal stress score low, however she would never encumber the taxpayers of the County just so we would receive a low score that only looks at one portion of our total funds. In 2018, sales tax has increased, and we will most likely end the year with an additional \$1 million or more in sales tax revenue.

County Administrator - Michael Zurlo

Mr. Zurlo reported he attended the New York State Association of Counties (NYSAC) conference Monday, September 24th through Wednesday, September 26th in Rochester, New York. One of the issues discussed was Raise the Age. Many upset people are talking about concerns with reimbursement and plans as to where these youthful offenders will be housed. The State has reassured everyone that has been accounted for in the State's fiscal plan. Clinton County's fiscal plan has been submitted to the State. The Raise the Age Law goes into effect on October 1, 2018.
