Particular attention should be the potential for junk cars to remain on lot if there tenant has the intention to use junk cars for parts salvage. Parking for vehicles related to this tenant should be given designated locations on site
  - o No parking should be allowed along the Military Turnpike, and no vehicles should be stored long term in the Military Turnpike right-of-way.
- Signs related to this business should be outside of the right-of-way to ensure proper lines of site entering and exiting the location.
- The Town is encouraged to require that any expansion/change to this business require a new application and approval by the Town Planning Board.
