All tree clearing work shall be performed between **October 31**st, **2018 and March 31**st, **2019**.

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wage rates as a minimum in accordance with the current Federal and State Wage Rate Schedules. Bidders shall be advised that this contract requires participation by certified disadvantaged businesses as follows: **DBE Goal: 2.33%.**
