AWARDING BID FOR AIR CARGO RDC/GENERAL AVIATION CUSTOMS FACILITY AND MULTI-MODAL TRANSIT FACILITY PROJECT – PLATTSBURGH INTERNATIONAL AIRPORT

WHEREAS, Resolution #200 dated March 8, 2017 accepted the New York State Department of Transportation (NYSDOT) Grant in the amount of \$38,045,000 for the Upstate Airport Economic Development and Revitalization Grant Program; and

WHEREAS, this Grant Program includes the Upstate Airport Initiative (UAI) Projects consisting of: demolition of eight (8) abandoned buildings, construction of four (4) new buildings (Air Cargo Receiving and Distribution Center (RDC) facility, General Aviation Federal Inspection Station (FIS)/Customs and Border Protection facility, Light Industrial Manufacturing Facility and a Multi-Modal Public Transit building); and renovation of seven (7) buildings; Rehabilitation of Central Terminal Parking Lot; Terminal Building Concession Space Build-Out; FIS Boarding Bridge Construction; and Development of Access Road and Parking for Retail Business Site; and

WHEREAS, Resolution #402 dated May 24, 2017 authorized the County Treasurer to establish the capital project for the Air Cargo RDC/General Aviation (GA) Customs Facility to be funded by the Upstate Airport Economic Development and Revitalization Grant Program; and

WHEREAS, this Project included an estimated construction cost in the amount of \$10,080,000; and

WHEREAS, Resolution #404 dated May 24, 2017 authorized the County Treasurer to establish the capital project for the Multi-Modal Transit Facility to be funded by the Upstate Airport Economic Development and Revitalization Grant Program; and

WHEREAS, this Project included an estimated construction cost in the amount of \$550,000; and

WHEREAS, both Projects were combined into UAI Bid Package No. 7 in an effort to generate more opportunities for bidders by providing the option to bid the projects separately (Bid Option 1) or combined (Bid Option 2); and

WHEREAS, Resolution #667 dated August 23, 2017 authorized the Purchasing Agent to solicit bids for the UAI Projects, including the Air Cargo/GA Customs Facility and Multi-Modal Transit Facility; and

WHEREAS, bids were opened for this Project on February 6, 2018 and submitted as follows:
