WHEREAS, additional bids were submitted for Add Alternates; however, these amounts have not been included as the Airport has recommended these not be awarded; and

WHEREAS, Resolution #774 dated September 27, 2017 authorized acceptance of the Airport Improvement Program (AIP) Grant #3-36-0229-058-2017 whereby the Federal share of the project is 90 percent (\$898,329), New York State share being 5 percent (\$49,907) and Clinton County share being 5 percent (\$49,908) for the renovation of the ARFF Building; and

WHEREAS, some costs associated with this Project were deemed ineligible for AIP Grant funding, requiring the County to provide an additional twenty-eight percent of the costs associated with the Base Bid and Allowances for each contract (total amount \$986,376; \$922,000 general construction plus \$64,376 electrical contract) in an amount of \$276,185; and

WHEREAS, the bids have been reviewed and found to be in order by Project Engineer, C & S Engineers, Inc.; and

WHEREAS, the contractors have been found to be responsive and responsible bidders and, based on their qualifications and experience on similar projects, C & S Engineers, Inc. recommends award for the following construction contracts; now, therefore,

BE IT RESOLVED, the Clinton County Legislature hereby awards bids to the lowest responsible bidder for each of the two contracts (Murnane Building Contractors, Inc. for general construction and Dow Electric, Inc. for electrical construction); and

BE IT FURTHER RESOLVED, the Clinton County Legislature hereby authorizes the Chairperson to execute all necessary documents for the following:
