## AUTHORIZING THE PURCHASING AGENT TO AWARD THE BID TO ACQUIRE AIRCRAFT RESCUE AND FIRE FIGHTING (ARFF) PERSONAL PROTECTIVE EQUIPMENT (PPE) PROJECT – PLATTSBURGH INTERNATIONAL AIRPORT

WHEREAS, Resolution #162 dated February 26, 2020 authorized the Purchasing Agent to solicit bids to Acquire Aircraft Rescue and Fire Fighting (ARFF) Vehicle and Personal Protective Equipment (PPE) Project at the Plattsburgh International Airport; and

WHEREAS, Resolution #529 dated September 9, 2020 authorized grant acceptance of Federal Grant Agreement AIP #3-36-0229-067-2020 for the ARFF PPE Project at the Plattsburgh International Airport; and

WHEREAS, Resolution #551 dated September 23, 2020 rejected the original bid received for the ARFF Vehicle and Personal Protective Equipment (PPE) as the vehicle was deemed ineligible for Federal grant funding at this time; and

WHEREAS, a second bid was solicited for the Personal Protective Equipment (PPE) only; and

WHEREAS, only ARFF PPE turn out gear consisting of jackets, pants, boots and helmets are considered eligible for Federal grant funding as part of this bid; and

WHEREAS, bids for PPE were opened on May 21, 2020 and submitted as follows:

WHEREAS, the bids have been reviewed and found to be legally sufficient by the County Attorney; and

WHEREAS, the bid from Garrison Fire and Rescue Corporation has been reviewed by the Project Engineer, C & S Engineers noting that pricing was submitted for only 38 of the 67 PPE equipment items, missing a price for one item of turn out gear; and

WHEREAS, the bid from Municipal Emergency Services, Inc. has been reviewed by the Project Engineer, C & S Engineers noting that pricing was submitted for 66 of the 67 PPE equipment items, including all items for turn out gear; and

WHEREAS, the bid proposal from Municipal Emergency Services, Inc. for ARFF PPE turn out gear is \$11,491.08; and

WHEREAS, Clinton County is in receipt of the Federal Aviation Administration's (FAA) concurrence of award for ARFF PPE consisting of turn out gear only, and the Engineer's recommendation of award of the contract in the amount of \$11,491.08 to Municipal Emergency Services, Inc.; now, therefore,

BE IT RESOLVED, the Clinton County Legislature hereby awards the bid for ARFF PPE turn out gear to Municipal Emergency Services, Inc.; and
