Sealed proposals for the construction of Runway 17 On-Airport Obstruction Removal – Phase II Contract will be received at the Legislative Office, Clinton County Government Center, 137 Margaret Street, Suite 208, Plattsburgh, New York 12901 until 2:30pm, local time, **June 23, 2016**, and there, at said office, at said time, publicly opened and read aloud.

This project generally includes the removal of obstructions at and adjacent to the Runway 17 end at Plattsburgh International Airport. Specifically, work includes the excavation, removal, and re-grading of approximately 60,000 CY of earthen material located adjacent to the Runway 17 end.

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wages rates as a minimum in accordance with the current Federal and State Wage Rate Schedules.

The Contract Documents (consisting of the Advertisement, the Proposal, the Contract Form, and the Specifications) and the Contract Drawings may be obtained only from the Airport Manager's Office, Plattsburgh International Airport, 42 Airport Lane, Suite 201, Plattsburgh, New York 12903, Phone (518) 565-4463, upon deposit of fifty dollars (\$50.00) per bid set. Each bid set will consist of two (2) identical copies of the aforementioned contract documents and contract drawings. The proposals in each book must be completed (no copies) and both books submitted as a part of the bid. Deposits shall be check only and made payable to **Clinton County Treasurer**.

Any Contract Document holder, upon returning the entire bid set in good condition within thirty (30) days of the award of contract, or rejection of proposals, will be refunded the full amount of his/her deposit. Parties failing to conform to the above conditions within the prescribed allotted time shall forfeit their deposits as heretofore set forth and shall have no recourse against Clinton County for a refund of the Contract Documents deposit.

Each proposal must be accompanied by a certified check or bid bond, in the amount of five percent (5%) of the total maximum proposal price (combination of base bid or alternate bid plus add-on items) for the

contract in the form and subject to the conditions provided in the Preparation of Proposal. Such certified check or bid bond shall be made payable to **Clinton County Treasurer**.

A pre-bid conference is scheduled for **June 15, 2016** at 11:00 a.m. at the Plattsburgh International Airport ARFF Building conference room, Arkansas Street, Plattsburgh, New York 12903 in order to review the specific requirements of this contract. All prospective bidders are encouraged to attend.

The County and their agents reserve the right to review and approve the Project Manager and Superintendents scheduled for each Prime Contractor. If said personnel are not accepted, they may not act in any manner of the administration, management or supervision in or during any part of the project. The contractor will present other candidates within five days for acceptance upon denial of previously submitted personnel. No extension of time nor expense will be granted in either case.
